Refund Policy

PlanKori is committed to providing high-quality services. However, due to the nature of digital services, refunds are only available under specific conditions outlined below:

- 1. General Refund Policy
- 1.1 Refunds are only applicable if PlanKori fails to deliver the agreed-upon service as described at the time of purchase.
- 1.2 No refunds will be issued once work has commenced, unless otherwise stated in a specific service agreement.
- 1.3 If a service is delayed due to incomplete or incorrect information provided by the client, refunds will not be issued.
- 1.4 Refund requests must be submitted within 7 days of service completion.
- 1.5 Approved refunds will be processed within 10 business days using the original payment method.
- 2. Payment Method Formation Refunds (Stripe, PayPal, Wise, etc.)
- 2.1 Refunds will not be provided if the account application is rejected by the respective payment provider (e.g., Stripe, PayPal, Wise), as PlanKori only facilitates the process and has no control over approval decisions.
- 2.2 If an application is incorrectly submitted due to PlanKori's error, we will attempt to correct it or offer a partial refund.
- 3. Web Development, SEO, Graphic Design, and Video Editing Refunds
- 3.1 No refunds will be issued for completed or partially completed projects.
- 3.2 If a project is canceled before work has begun, a 50% refund may be issued, deducting administrative fees.
- 3.3 Dissatisfaction with the final project does not qualify for a refund; revisions can be requested as per the service agreement.
- 4. Web Server Solutions Refunds
- 4.1 Refunds are not available for server setup, maintenance, or troubleshooting services once performed.
- 4.2 If a technical issue arises due to PlanKori's error, we will resolve it at no extra cost.
- 5. Company Formation (LLC/LTD) Refund Policy
- 5.1 Refunds are not available once the company registration process has been initiated.
- 5.2 If the application is rejected due to an error on PlanKori's part, we will correct it at no additional charge.
- 5.3 If a client voluntarily cancels the company formation process after submission, no refund will be provided.
- 5.4 Government fees, legal fees, and third-party charges are non-refundable.
